- COVID Update:
  - o County positivity rates remain in high transmission, masking has not changed.
- Maintenance Garage:
  - o Concrete has been completed on the new garage build.
- Marketing:
  - o The Hospital is working on the newsletter, this will be sent out in the next couple months.
  - o Planning for the Health fair to be held in the fall of 2023.
- The Heiam Foundation has donated \$50.00 gift cards to all employees of the Hospital to celebrate and give thanks during the Holiday Season. They also donated four Keurig coffee pots, 3 will be in the Hospital and 1 in the Clinic.
- The City of Cook Ambulance Director notified us they will be down an ambulance until at least February due to it needing it a new engine.

## b. Facility Assessment Care Center - Teresa Debevec

- i. Debevec provided the updates of the Facility Assessment in the Care Center due to new regulations passed in October 2022. Cook Hospital is required to conduct, document, and annual review a facility-wide assessment, which includes both our resident population and the resources we need to care for our residents. This will ensure compliance with (§483.70(e)).
  - 1. Overview of the Assessment Tool:
    - **a.** Resident profile including numbers, diseases/conditions, physical and cognitive disabilities, acuity, and ethnic/cultural/religious factors that impact care
    - **b.** Services and care offered based on resident needs
    - c. Facility resources needed to provide competent care for residents, including staff, staffing plan, staff training/education and competencies, education and training, physical environment and building needs, and other resources, including agreements with third parties, health information technology resources an systems, a facility-based and comminute-based risk assessment, and other information regarding overall care.
    - d. Emergency Preparedness Plan and activities including preparation and action plans
    - **e.** Infection Prevention policies and procedure including general IP policies, employee illness, emerging infections response and monitoring and reporting requirements.


